Hundiwale, Prof. Dr. Nerkar M. H. and Prof. S. G. Adam had expressed their inability to attend the meeting due to some unavoidable circumstances, and therefore leave of absence was granted to them.

With the permission of chairman the proceeding of BoS started.

## Item No 1

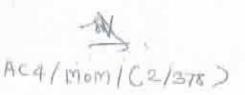
To read and confirm the minutes of third meeting of Academic Council held in the meeting hall of institute on 08/05/2015.

- 1.1 Hon Chairman academic council requested to approve the modified academic council (refer item no 16a) and grant permission to new members/invitee members to attend the meeting. It was approved and all new members/invitee members were permitted to attend the meaning.
- 1.2 The minutes of the third meeting of Academic Council held on 08/05/2015, were read and confirmed unanimously without any modification.

## Item No 2

To note and approve the action taken by institute on the agenda points discussed and resolved in the earlier meetings of Academic Council.

- 2.1 The action taken by institute on the agenda points discussed and resolved in the earlier meetings of Academic Council were briefed by Dean Academics Prof. S. O. Dahad.
- 2.2 Prof Dr. A. M. Mahajan enquired about the delay in the submission of reports of subcommittees appointed in earlier meeting and expressed his expectation about the receipt of report at the earliest (within two weeks).
- 2.3 The same were noted and approved



#### Item No 3

To note the minutes of meeting of third meeting of Examination Committee and discuss/approve the suggestions given by it.

- 3.1 The third and fourth meetings of Examination Committee were held on 18<sup>th</sup> September 2015 and 20<sup>th</sup> April 2016 respectively in the meeting hall of the Institute. Dean Academics Prof. S. O. Dahad briefed about highlights of the proceedings of the meeting.
- 3.2 Academic Council noted the same.
- 3.3Two important points regarding institution of gold medal and to incorporate moderation of answer books in the evaluation process of ESE answer books were discussed and approved as separate agenda item (Item No 16b and 16c).

#### Item No 4

To note the suggestions of second meeting of Finance Committee related to academic matters.

The second meeting of Finance Committee was held on 20th February 2016 in the meeting hall of the Institute. Member Secretary of Finance Committee – Technical Registrar briefed about highlights of the proceedings of the meeting.

#### Item No 5

To discuss and approve the suggestions received from various BoS about the course GP-II and other vourses of F, Y, B, Tech.

- 5.1 It is resolved to keep evaluation pattern of the course G.P. II as it is:
- 5.2 It is unanimously approved to shift this subject in even semester from the academic year 2016 17 for the three branches viz Electrical, Computer and Civil Engineering to overcome the various difficulties fixed by institute during current academic year. Accordingly, curriculum structure prepared and approved by concerned BoS were approved.
- 5.3 It is also unanimously approved to change the ESE duration of the course ME151 Engineering Graphics to four hours.

#### Item No.6

To discuss and approve the detailed syllabus of T. Y. B. Tech. (Electronics and Telecommunication) as approved and submitted by its BoS for approval of AC.

6.1 Detailed syllabus of T. Y. B. Tech. (Electronics and Telecommunication) as approved and submitted by its BoS was discussed at length. Shri Anirudh Pandharkar suggested taking feedback from students about the industrial lectures delivered by industrial experts and the same may be effectively used in the next.

7.3 The suggestion of BoS Mechanical to change the rule of maximum option in ESE question paper up to 40 % was also discussed at length and not approved.

To discuss and approve the detailed syllabus of T. Y. B. Tech. (Instrumentation) as approved and submitted by its BoS for approval of AC.

8.1 Detailed syllabus of T. Y. B. Tech. (Instrumentation) as approved and submitted by

its BoS was discussed at length.

8.2 Academic Council approved the same with few modifications of formatting. AC authorised BoS chairman to make necessary changes and submit final copy of detailed syllabus to chairman, academic council. Accordingly modified and final copy of detailed syllabus received from BoS chairman is enclosed as Annexure III.

#### Item No 9

To discuss and approve the detailed syllabus of T. V. B. Tech. (Electrical) as approved and submitted by its BoS for approval of AC.

 Detailed syllabus of T. Y. B. Tech. (Electrical) as approved by the BoS (Electrical) was discussed at length. During discussion, some members opined that the change in approved curriculum structure should not be permitted. On this point; Prof. G. K. Andurkar explained that BoS (Electrical) unanimously recommended inclusion of MOOCs / Mini Project as alternative to self study. It was



acknowledged by Prof U N Shete - chairman BoS (Mechanical). Prof. A M. Mahajan and Prof. R J Ramteke welcomed the idea of inclusion of MOOCs. Charman Prof. Dr. R P Borkar briefed the philosophy of self study and Prof. Dahad S. O. explained the modes of operandi for the execution of the course self study. In addition, Prof. Dr R. P. Borkar pointed that MOOCS are allowed as audit courses. After the discussion, Prof. Dr. A. M. Mahajan and Prof. Dr. R J Ramteke opined that though the concept of MOOCs is good; it cannot be treated equivalent to self study, mini project or industrial lectures. The other Boards of studies namely Computer, Instrumentation, E& T/C, Civil were reluctant to include MOOCS as credit courses at this juncture because it cannot be the alternative for self study, industrial lectures and mini project.

- 9.2 Some members were doubtful about methodology for implementation or uniform assessment or appropriate grading to all students of one class who are opting the different courses falling under the common title "self study/industrial lecture/mini project". In addition; one question was unanswered that who and how the syllabus of self study will be taught to the students who are not opting the course self study?
- 9.3 Most of the members were of the opinion that MOOCs may be included in curriculum as credit course in the next phase of curriculum revision which may be from the academic year 2017-18.
- 9.4 Listening all opinions, on the basis of majority it is resolved that BoS (Electrical) is not allowed to do these structural changes in the corriculum at this juncture.
- 9.5 AC authorised to chairman BoS (Electrical) to make necessary changes/ modifications in the detailed syllabus of T. Y. B. Tech. (Electrical) so as to make it as per the structure approved in earlier meetings of AC. These changes shall be: subsequently ratified in the next meeting of BoS. Accordingly modified and final copy of detailed syllabus received from BoS chairman is enclosed as Annexure IV.
- 9.6 Changes in syllabus of S. Y. B. Tech (Electrical) suggested by its BoS were approved unanimously. Accordingly modified and final copy of detailed syllabus received from BoS chairman is enclosed as Annexure V.

#### Item No 10

To discuss and approve the detailed syllabus of T. Y. B. Tech. (Computer) as approved and submitted by its BoS for approval of AC.

10.1 Detailed syllabus and some changes in the title of courses of T. Y. B. Tech. (Computer) as approved and submitted by its BoS were discussed at length.

10.2 Academic Council approved the same with few modifications of formatting AC authorised BoS chairman to make necessary changes and submit final copy of



detailed syllabus to chairman, academic council. Accordingly modified and final copy of detailed syllabus received from BoS chairman is enclosed as Annexure VI.

#### Item No 11

To discuss and approve the detailed syllabus of T. V. B. Tech. (Civil) as approved and submitted by its BoS for approval of AC.

11.1 Detailed syllabus and some changes in the title of courses of T. Y. B. Tech. (Civil)

as approved and submitted by its BoS were discussed at length.

11.2 Academic Council approved the same with few modifications of formatting. AC authorised BoS chairman to make necessary changes and submit final copy of detailed syllabus to chairman, academic council. 12.1 Modifications suggested by various BoS, EC, FC and faculty members of this institute and compiled by Dean (Academics) of the institute were discussed at length.

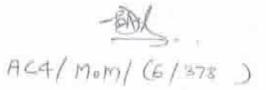

#### Item No 13

To discuss and approve modifications in the exumination rules.

13.1 Modifications suggested by various BoS, EC, FC and faculty members of this institute and compiled by Dean (Academics) of the institute were discussed at length.

13.2 Regarding modification in remuneration rates; Prof. S. O. Dahad informed to AC that, the remmeration rates of class IV working over the year for AEC activities are also approved by APEC on yearly basis which are not included in the suggested modifications. It was approved as Rs 4000, Rs 6000 and Rs 7000 for the academic year 2015-16, 2016-17 and 2017-18 onward respectively. In addition, Prof. G. K. Andurkar suggested replacing the word 'Other rates as suggested by EC' by the word 'Other rates and modifications in remmeration as suggested by Chairman EC' as EC had already authorised to Chairman EC for the referred work. It was also unanimously approved.

16a: To note the changes in various Board of Studies, APEC, Academic Council and Board of Management.

16a.1 AC noted the changes in BoM and approved the changes in other authorities of autonomy.

16a.2 AC suggested concerning BoS to replace the BoS members who are not attending the meetings or otherwise re-constitute the BoS and submit in the next meeting of AC for approval.

# 16h To accord approval to the "Institution of Gold Medal"

16b.1 With respect to this subject; the recommendations of Examination Committee and the report submitted by sub-committee were discussed at length and accepted unanimously.

16b.2 The regulation "Institution of Medals" is incorporated in autonomy rules at the

- 16c To incorporate moderation of answer books in the evaluation process of ESE answer books.
- 16c.1 With respect to this subject; the recommendations of Examination Committee were discussed at length and accepted unanimously with some modifications/additions stated below.
  - Marks awarded by moderator shall be final except the cases falling under following points.
  - After moderation if it is found in case of 50 % or more number of moderated answer books; the change in marks is more than 20 % of maximum marks then Asst. CoE (Post. Exam) shall convene the meeting of all evaluators and moderator to receive uniform evaluation scheme. If required; evaluators shall reevaluate all the answer books as per uniform evaluation scheme without any additional remuneration.
  - After moderation if it is found in case of 75 % or more number of moderated answer books—evaluated by one evaluator has one sided (either increase or decrease) change in marks then Asst. CoE (Post. Exam) shall convene the meeting of all evaluators and moderator to receive uniform evaluation scheme. If required; evaluators shall re-evaluate all—answer books as per uniform evaluation scheme without any additional remuneration.
- 16c.2 "Moderation" is incorporated in examination rules at the appropriate place and its copy is enclosed as Annexure IX.
- 16d Shri Antrudha Pandharkar enquired about employability of our students and Training & Placement activities undertaken by institute.
- 16d.1 Prof. U. N. Shets, nodal officer industry institute interaction; had given the placement status as on date for the current academic year and information about various activities of training and placement cell.
- 16d.2 Principal Dr. R. P. Borkar given additional information to AC about the efforts taken by college to enhance the employability of students.
- 16d.3 AC is not happy with the placement of the final year students and expect better in future.

Meeting concluded with vote of thanks by Prof. S.O. Dahad

Apart from the various academic items discussed and reported in the above proceeding of the fourth meeting of academic council; one excruciating incident as briefly described herewith occurred in the same meeting at around 11.00 to 11.15 am in the presence of all members. "Prof. Dr. Y. U. Sathe; Assistant Professor in Mechanical Engineering all of sudden entered in the meeting hall and started his saying arrogantly to the Principal (Chairman, AC)



without his prior permission in non-parliamentary language, aggravating voice and misbehaved with the Principal. He thrown away and broken the Principal's breakfast plate, scattered the Principal's papers and continued his saying in the same manner. Hon member Prof. Dr. A. M. Mahajan and Prof. Dr. R. J. Ramteke tried to calm down him and requested to speak and behave properly to maintain the decorum of meeting. In addition; they also suggested him to discuss his matter after that meeting. But still be continued saying and warned all the members to put in trouble to all of them in future and left the meeting hall after around 15 minutes".
