## Guidelines regarding examination from Government of Maharashtra

2 Online meeting held on 12 May 2020 in the presences of Heads / Deans ,CoE ,Pre Coe, Post CoE and concerned faculties

As we all know that due to Covid -19 pandemic whole world, including India is passing through unprecedented difficult times. Hence guidelines are issued as per above reference letter by committee constituted by Hon Minister-H&TE ,Government of Maharashtra regarding the summer 2020 examinations and further academic calendar. This information is brought to the notice students after discussion and as per guidelines of GoM .These guidelines should be kept before the regulatory authorities and bodies for suggestions /decisions if any

1 Examinations (Theory and Practical) will be held for Final year 8<sup>th</sup> semester students and for those 8<sup>th</sup>sem students having backlog of the earlier semester 5, 6 or 7<sup>th</sup>semester.

2 Practical Examination will be held of Final year 8<sup>th</sup> semester students and those 8<sup>th</sup> sem students having backlog of practical's of the earlier semester 5, 6 or 7<sup>th</sup> semester.Practicals will be conducted in small batches in order to follow the physical distancing .

3 Examination for Final year 8<sup>th</sup> semester students will be conducted during the period of 01 -31 July 2020 keeping in the view the physical distancing. Time table and mode of Exam will be displayed in due period of time after approval. Question papers will be based on syllabus completed till 13 March 2020 and self-study portion for respective subject as per guidelines. The syllabus for exam will be uploaded on website /communicated by concerned department for respective final year subjects department wise.

4 As per guidelines, the grading / results of the students studying in the 2<sup>nd</sup>, 4<sup>th</sup>, and 6<sup>th</sup> semester will be declared without conduction of examination as per guidelines of GoM

The grading will be done based upon 50 % weightage to internal assessment and 50 % weightage to average of earlier semester marks.

5 If the students mentioned in para 4 want to improve the grades after grading/ result as per above, He/she can appear for the examination in next semester (Winter 2020) after filling the examination form.

6 If the students mentioned in para 4 have earlier semester backlogs, theory and practical examinations will not be conducted now. But the Examinations of such students will be

conducted in the next four months based on the examination form filled for such examinations.

7 Students with backlogs / failed due to such grading will be promoted to new year/semester for this academic year only i.e. 2020-21. But he/she has to clear the backlog courses examination whenever the exams are scheduled in the coming semester.

8 The period of lockdown will be considered as deemed to be attended in second semester of 2019-2020

9 Committees are formed at the institute level for deciding the Grading and mode / pattern of examinations

10 For information and helping students regarding examination guidelines in covid-19 situation the facilitation committee is formed in the institute .Students can write queries regarding examination only in decent manner and should sent E-mail to [gcoej.examcell@rediffmail.com](mailto:gcoej.examcell@rediffmail.com) and a cc- copy of same email to the concerned departments faculty members E-mail .The committee is as follows
