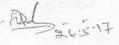

Award of Grades in backlog examination—
For the award of grades to any course of backlog examination; statistical data used for award of grades for that course at the preceding regular examination in that academic year shall be

used.

11.3 It was discussed and approved as it was the typographic error in the rule.

To note and discuss the result analysis of Summer 2016, Re-exam 2016 and Winter 2016 examination. (Agenda point presented by Hon. Result Analysis Coordinator)

12.1 Detailed result analysis of summer 2016, re-exam 2016 was noted and result analysis coordinator informed to academic council that the result analysis of Winter 2016 examination was not ready due to MIS problem.
